Resolved further that all transactions done by the mandated users through the Corporate Net Banking are authorized transactions and will be binding on the BANK/Society/Corporate. The company does agree to hold The Tamil Nadu State Apex Cooperative Bank Ltd., harmless for providing access to carry out the transactions.

The Officials authorized by the Board to present the mandate to the Bank for transacting on the account will appoint a Local Administrator (who will be single point of contact between the corporate and TNSC BANK) to verify / monitor the veracity of the transactions put through Net Banking. The application form be duly filled and handed over to the Bank under the signature of the Officials authorized in this Board Resolution. The role level mapping of the various hierarchies of users for the Bank/Society/Corporate under the Corporate Net Banking, with specified powers for viewing, initiating and or approving transactions in a single or multiple levels has the desired authority by this Resolution.

Resolved further that to confirm and accept that the risk factors relating to Corporate Net Banking have been duly explained to us by TNSC BANK and we hereby consent to the same. Further Resolved that the Bank/Society/Corporate shall not hold TNSC BANK responsible for any Conversion or any misuse of the net Banking facility availed by the Corporate / Society/ the BANK.

Further Resolved that a copy of the resolution be submitted to The Tamil Nadu State Apex Cooperative Bank Ltd., duly certified by the Chairman of the meeting of the Board.
